

PEI Model Forest Network Program Fall/Winter 2010 Photo Contest

Official Photo Contest Rules, Regulations and contest entry information

1. Entries shall be Electronic submissions as jpeg files and must include name, address, Phone number and Email, as well location of photo and optional caption. All entries shall be sent to gregmodelforest@gmail.com with the entry information and image file included as attachments. Upon submission of image, entrant agrees to all subsequent rules and regulations as stated below.

2. The photo contest runs from October, 22, 2011 through, Feb, 29, 2012. Entries must be submitted by the contest closing date of February, 29, 2012. The PEI Model Forest Network Program is not responsible for entries that are lost, late, delayed, misdirected, unintelligible, illegible, and incomplete.

3. There is a limit of three entries per person. Each submission must include a separate entry form. Photos containing identifiable people must also be accompanied by a model release form. Model releases are the responsibility of the entrant and must be available in the event the photo is a winner. Numerous entries do not require separate email messages.

4. Acceptable entries must have an original file resolution of 3.1 megapixels minimum. For all entries, original material, including capture file must be available for reproduction purposes. All entries and contest materials received become property of the contest organizers and sponsors and will not be returned.

5. To be considered in the contest, all submissions must be original, current, unpublished photographs taken of or in the forests of Prince Edward Island.

6. By completing and submitting the PEI Model Forest Network Photo Contest entry form, the contestant grants the organization and sponsors the unrestricted and exclusive rights to use photograph(s) for any purpose. This includes, but is not limited to, publishing your photograph(s) in print or electronic form for promotional purposes without further compensation, and the right to use the photographers name as a credit along with the photograph. The photographer must own all rights to any photographs entered in this contest. It is the responsibility of the contestant to ensure that publication of the photographs raises no legal claims. Accordingly, you hereby agree to compensate the sponsors fully regarding any claims arising out of the use of your photograph(s).

7. Limit of one (1) prize per person or household.

8. Prior to receiving a prize, the winners will be required to sign an agreement declaring that a) he or she does not sell photographs or charge a fee for taking pictures; b) the photography submitted is his or her original work; c) the photography was taken at the location specified on the entry form.

9. All prizes must be accepted as awarded, and are not convertible to cash.

10. No mechanically or electronically altered entries will be accepted. Only the photographer has the right to submit a photograph and the photographer must complete each entry form. Prizes will be awarded to the photographers only.

Eligibility: The PEI Model Forest Network Photo Contest is open to any amateur photographer who lives in or visits Prince Edward Island. Judges and board members and/or their immediate family members are excluded from competition.

Judging: A panel of judges will judge eligible entries. All decisions of the contest judges are final.

By completing the entry form, the participant consents to entry of his or her submission and agrees to these Official Rules and Regulations and the decisions of the judges, which are final and binding in all matters to this contest
